ENTRY FEE:	MEMBERS	\$288.75 (275.00 + 13.75 GST)
	NON-MEMBERS	\$393.75(375.00 + 18.75 GST)
	PLUS	3% COMMISSION PAYABLE ON HORSES SOLD OR RESERVE IF NOT SOLD

- 1) OUTSIDE HORSES, INCLUDING OUT OF PROVINCE HORSES MAY BE CONSIGNED AT THE NON-MEMBER FEE. ANY NON-MEMBER WITH MORE THAN ONE CONSIGNMENT MUST BECOME A MEMBER, EXCLUDING OUT OF PROVINCE.
- 2) **THE CONSIGNOR AGREES TO GUARANTEE THE HORSE TO BE SOUND AND AS REPRESENTED. THEREFORE IF ANY CONDITION OR UNSOUNDNESS ARISES THAT IS PROVEN, TO THE SATISFACTION OF THE SALE COMMITTEE, TO BE A FAULT AT SALE TIME, THE CONSIGNOR MUST BUY THE HORSE BACK.**
- 3) VETERINARY CERTIFICATE IS REQUIRED FOR ALL NOMINATED HORSES BEING WITHDRAWN FROM THE SALE. **NO EXCEPTIONS.**
- 4) SUBSTITUTIONS WILL BE CONSIDERED WITH A MINIMUM OF SEVEN (7) DAYS PRIOR NOTICE AND SUBJECT TO ACCEPTANCE BY THE SALE COMMITTEE. SEE RULE #4 ABOVE.
- 5) IF CONSIGNOR DOES NOT ELECT TO SUBSTITUTE FOR A NOMINATED HORSE WHICH IS WITHDRAWN, THE CONSIGNOR MAY REQUEST A \$200.00 CREDIT TOWARDS THE ENTRY FEE FOR THE FOLLOWING YEAR'S AQHGB SALE.
- 6) IF AN ENTRY ARRIVES LAME OR IN POOR CONDITION, THE CONSIGNOR WILL BE TURNED AWAY AND HE WILL FORFEIT HIS ENTRY FEE. ALL DECISIONS WILL BE MADE BY THE SALE COMMITTEE AND WILL BE FINAL.
- 7) IMPRESSIVE BREEDING MUST HAVE PROOF OF N/N HYPP BY VET CHECK DATE OR HORSE WILL NOT BE ALLOWED IN TO THE SALE.
- 8) ALL MARES NOMINATED AS **BROODMARES** MUST HAVE VETERINARY PROOF OF PREGNANCY WITHIN 30 DAYS OF THE SALE DATE. **NO OPEN MARES WILL BE ACCEPTED AS BROODMARES.**
- 9) ENCLOSE WITH YOUR NOMINATION FORM, AQHA SIRE/DAM REPORTS, THE CORRECT ENTRY FEE, ORIGINAL PAPERS AND A SIGNED TRANSFER. ALL ENTRIES **MUST** BE ACCOMPANIED BY FOUR (4) COLOURED PHOTOS, ONE FROM EACH SIDE PLUS ONE EACH FROM THE THE FRONT AND REAR. **NOTE:** IT IS IN THE CONSIGNOR'S BEST INTEREST TO SUBMIT GOOD, QUALITY PHOTOS AS THE SALE COMMITTEE USES THESE PHOTOS TO HELP DECIDE ON ACCEPTANCE TO THE SALE. ALSO, ONE PHOTO WILL GO ONTO THE AQHGB SALE WEB SITE. PLEASE PUT HORSES & CONSIGNORS NAMES ON THE BACK OF EACH PHOTO. **IF YOU DO NOT PROVIDE THE AQHA RECORDS, THEY WILL NOT BE PROVIDED FOR YOU. EVERY AQHA MEMBER IS ALLOTTED \$10/MONTH FOR RECORDS.**
- 10) THE BREEDERS' GROUP WILL PROVIDE NEW HALTERS AND LEAD SHANKS FOR EACH HORSE THAT IS SOLD. THAT COST WILL BE DEDUCTED FROM THE SELLING PRICE OF THE HORSE (APPROXIMATELY \$40.00).
- 11) AWARDS WILL BE PRESENTED TO HIGH SELLING HORSE IN 5 CATEGORIES TO BOTH THE BUYER AND THE CONSIGNOR. IN CASE OF A TIE, THE WINNER WILL BE DECIDED BY A COIN TOSS. **SPONSORED BY FLAMAN SALES, YELLOWHEAD AND KUBOTA DEALERS OF ALBERTA.**
- 12) NO HORSES ARE ALLOWED TO LEAVE THE BARNs UNTIL THE HIGH SELLERS HAVE BEEN DETERMINED AND PICTURES HAVE BEEN TAKEN.
- 13) \$8000.00 CASH PAYOUT TO THE CONSIGNORS OF THE TOP TEN SELLING HORSES ON A GRADUATED SCALE WITH THE OVERALL HIGH SELLING HORSE RECEIVING \$1600.00. SHOULD THERE BE A TIE, THE PAYOUT WILL BE ADDED TOGETHER AND DIVIDED BY THE NUMBER THAT IS TIED (SEE ATTACHED). **SPONSORED BY IMPERIAL DISTRIBUTORS CANADA INC.**
- 14) THE CO-PRODUCER, EDMONTON NORTHLANDS IS A LICENSED AND BONDED LIVESTOCK DEALER AND THEREFORE ACCEPTS RESPONSIBILITY IN THE CASE OF NON-PAYMENT UNDER THE LIVESTOCK PATRONS ASSURANCE FUND.
- 15) **YOU MUST CHECK YOUR HORSE'S PAPERS PRIOR TO ENTERING THE SALE TO ENSURE THAT THE MARKINGS/COLORS ARE CORRECT. THIS WILL ALLOW TIME FOR CORRECTIONS TO BE MADE IF NECESSARY, AS ALL PAPERS ARE INSPECTED AND MATCHED TO THE SALE ENTRY. INCORRECT ENTRIES WILL BE DECLINED FROM THE SALE, AND THE ENTRY FEE WILL BE FORFEITED. IF BRANDED, CONSIGNOR MUST ENSURE PROPER DOCUMENTATION IS IN PLACE.**
- 16) MEMBER'S ENTRIES WILL HAVE PREFERENCE, PROVIDING THEY ARE **TOTALLY COMPLETE** ON AUGUST 1, 2008.
- 17) **TRANSFER FEES WILL BE THE RESPONSIBILITY OF THE PURCHASER. AFTER ALL CHEQUES HAVE CLEARED THE BANK, THE ORIGINAL REGISTRATION PAPERS AND SIGNED TRANSFER WILL BE MAILED TO THE PURCHASER.**
- 18) PROPER ATTIRE MUST BE WORN IN THE SALE RING - WESTERN HAT, LONG SLEEVED SHIRT. AQHGB RECOMMEND THAT PROTECTIVE HEAD GEAR AND FOOT WEAR BE WORN BY PARTICIPANTS WHILE RIDING AT EVENTS HOSTED BY THE AQHGB.
- 19) **CONSIGNORS WILL PAY A 3% COMMISSION ON HORSES SOLD OR 3% COMMISSION ON THE RESERVE SHOULD THE HORSES NOT SELL.**
- 20) ALL SELECTED HORSES ARE EXPECTED TO BE PRESENTED IN SHOW CONDITION. THIS IS A SELECT SALE!
