This contract for the breeding season of 200__, is made and entered into on this _____ day of 200__, between _____, hereafter designated as breeder, and _____ hereafter designated as mare owner. Mare owner agrees to breed the mare _____, reg# _____ to _____ subject to the following conditions:

1. Stallion service fee is \$_____, which includes a non-refundable booking fee of \$150, payable when this contract is signed. The remainder must be paid before the mare leaves the breeders premises
2. Breeder agrees to provide suitable facilities for the care of the mare and/or foal while in her custody. Mare owner agrees to pay for feed and care at the rate of \$10 per day for the first 7 days and \$12 per day thereafter.
3. Breeder will exercise good judgment in the care of the mare and or mare/foal. Breeder's veterinarian may examine mare for normal breeding conditions and may administer medical care as deemed necessary for the health and safety of the mare and/or foal. All veterinarian expenses must be paid by mare owner.
4. Breeder will diligently try to settle mare, but, if mare fails to settle, mare owner will hold breeder blameless.
5. Mare owner shall bring the mare in healthy, sound breeding condition, free from infections and contagious or transmissible diseases. Mare is to be treated with strangles prevention and also it is recommended mare be inoculated against tetanus, influenza and rhinopneumonitis. Remove hind shoes. Breeder reserves right to refuse mare if not in good health.
6. A live foal is guaranteed providing the mare is ultra sounded pregnant with one embryo (not twins). A live foal is described as a new foal that stands and nurses. If the foal is born dead, there are return privileges only if breeder is notified within 7 days.
7. It is agreed that should the mare abort (after having been ultra sounded pregnant with one embryo), mare owner has return breeding privileges during the current breeding season with the cut off date being June 30, 200__ or the following year 201__ only. Breeder must be notified as soon as possible of the rebreed date. A \$150 chute fee will be charged for all rebreeds.
8. A breeder's certificate will be issued for the live foal from the registered mare named above, providing stallion and all other applicable fees have been paid in full.
9. Both parties agree that the breeder and /or any person associated with the breeder, is not liable for the death, sickness, theft and/or accident to the mare and/or foal;

and the mare owner is not liable for the death, sickness and/or accident caused to the stallion.

10. A.I. and shipped semen is available for additional charges. Please contact stallion owner for more information.

This contract is entered into in the province of British Columbia and will be interpreted and enforced under the laws of this province. When the mare owner and breeder sign this contract, it will be binding on both parties, subject to the above items and conditions.
