HORSE BOARDING AGREEMENT

FACILITIES

BOX STALL

- One inside 10 x 10 box stall.
- One outside exercise pen.

INDIVIDUAL PADDOCKS

- Paddock and shelter.

PASTURE BOARD

- Large paddock and pasture.
- Large three wall shelter.

FEED

INSIDE & OUTSIDE PADDOCKS

- A high quality hay and / or Alfalfa/grass cubes will be fed twice a day.
- Grain will be provided and fed at owner's request.
- If supplements are required, owner will provide them.

OUTSIDE PASTURE

- A high quality hay in winter.
- Large pasture in summer.

HORSE CARE

- The horse will be monitored regularly for health conditions.
- Any abnormalities will be reported to horse owner for specific instructions.
- If owner cannot be reached, a judgment will be made on the necessary action.
- Should veterinary services be required (unless prior arrangements have been made) the services of Stony Plain Veterinary Clinic will be used.
- Veterinary costs will be billed directly to the owner.
