## **CONSIGNMENT CONTRACT TERMS**

**Entry fee is \$446.25 ( \$425.00 plus 5% G.S.T.)**

**Entry fee deadline is July 30<sup>th</sup>, 2011**

**A 6% commission will be charged on all horses sold. There is a 5% commission on "pass outs". Pass-outs must be paid before the horse leaves the sales arena. It will be the consignors responsibility to establish reserve bids with the auctioneer. Transfer fees will be deducted from the sellers account. Buyers are advised that GST will be added to the sale price of each horse. Halters, and shanks will be provided for each horse sold, and deducted from the sellers account.**

**All horses selling at THE WESTERN HORSE SALE will be sold according to the laws of Alberta.**

**The following items are to be received by July 30<sup>th</sup>, 2011**

- A. Original registration paper**
- B. Current signed transfer**
- C. Summarized description of the sale horse**
- D. Clear, complementary picture of the sale horse to be used on the web site, (this item may follow later)**
- E. Livestock manifest filled out, dated for Sept 30th, 2011**
- F. Entry fee of \$446.25, payable to "THE WESTERN HORSE SALE".**
- G. Signed contract form. The seller warrants that the pedigree and papers to be correct and that all Information sent with this application to be true.**

**The seller warrants that each horse consigned is sound of HEART and LIMB, (unless otherwise stated), and free of any bad habits (i.e. weaving or cribbing), and not under the influence of medication. Violation of this clause will give the buyer the right to reject said horse. A CURRENT NEGATIVE COGGINS TEST IS MANDATORY! All horses in the sale are to be registered in proper breed associations, including foals.**

**All horses in the sale will be inspected at 9:00AM-12 noon in lot # order, on Friday, Sept 30th. Inspection will be for QUALITY, PRESENTABLE SHOW/SALE CONDITION, and VISABLE UNSOUNDNESS DUE TO INJURY OR CONFIRMATION. FAILURE TO HAVE HORSES IN PRESENTABLE SHOW/SALE CONDITION WILL GIVE THE SALE MANAGEMENT THE RIGHT TO REFUSE ACCEPTANCE TO THE SALE. No refunds. Some inspections will be done in advance of the sale.**

**All horses are to be presented by an owner or agent with the highest standard of conduct. Stall and bedding will be provided at no extra cost. Stall maintenance, feed and care of the sale horse, and return of the horse to the stalling area after presentation in the sale, is the consignors responsibility. Stalls will be decorated and pedigree signs posted. Additional decorating by consignors is welcome.**

**If a horse is unable to attend the sale, a substitution will be accepted, provided all necessary data accompanies the horse at sale time, otherwise the entry will be forfeited.**

**As each horse is sold, an "acknowledgment of purchase form shall presented to each buyer for signature. The horse then becomes the property of the buyer, who assumes all responsibilities and risks thereafter.**

**THE WESTERN HORSE SALE committee accepts no responsibility in the case of non-payments, but agrees to co-operate in every way possible to ensure the seller receives full payment or return of the horse. Transfer forms and original papers will be forwarded to proper breed Association.**
